- Enhanced Skills for Sustainable and Rewarding Employment (ENSSURE)-II is a bilateral initiative of the Government of Nepal (GoN) and the Government of Switzerland implemented by 3 tiers of government at Federal, Provincial and Local level with technical assistance from Helvetas Nepal. The overall goal of the project is to contribute for improved living standard of Nepalese workers particularly from disadvantaged groups to benefit from continuous employment.
- 2. Katahari Rural Municipality now invites Expression of Interest (EOI) from interested eligible Consultant or TPs to total Train 40 participants in Professional Cook and Professional Building Electrician (Level II with 1696 hrs. for each program) under Training with OJT in FY 2081/082 as mentioned in the Terms of Reference (TOR).
- 3. The training should be based on the minimum standards outlined in the CTEVT approved curriculum and National Occupational Skill Standards (NOSS) of the National Skills Testing Board (NSTB).
- 4. Interested eligible Consultant or TPs may obtain EOI document ate-GP system www.bolpatra.gov.np/egp.
- 5. The training events must be conducted in the venue/s having adequate training facilities for the proposed occupation/s. Conducting trainings in temporary (Mobile based) settings are not allowed and it should be conducted in the suitable location of Katahari Rural Municipality, Katahari, Morang.
- 6. Documents of the experience and other evidence copies of certificates shall be duly notarized.
- 7. Expressions of interest shall be delivered online through e-GP system www.bolpatra.gov.np/egp on or before 2081/11/06 at 12.00 pm.
- 8. Submitted Expressions of interest (EOI) will be opened in the presence of consultant or TPs representatives who choose to attend on 2081/11/06 2:00 PM at the office of Katahari Rural Municipality.
- 9. EOI will be assessed based on Qualification (35%), Experience (50%) and Capacity (15%) of the Training Providers and Key Personnel. Based on evaluation of EOI, only short-listed firms will be invited to submit Technical and Financial Proposal through Request of Proposal (RFP).
- 10. Minimum score to pass the EOI is 60 points.
- 11. Katahari Rural Municipality the right to shortlist or not shortlist any or all the applicant(s) without assigning any reason whatsoever.
